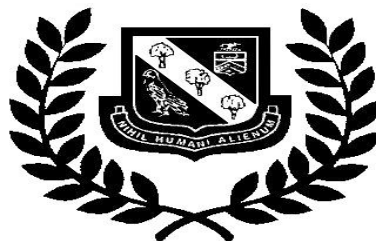

FEE NOTICE FOR 2012

Glenwood High School's fees for 2012 have been set at R26 670.00 for grades 9 – 12 and at R28 170 for Grade 8. This figure was approved by a General Meeting of parents held on 26 October 2011. In arriving at this decision various significant factors were taken into account. The facilities and education we provide at Glenwood are funded by the fees paid by parents. The Department of Education pays for 40 teachers at Glenwood and gives ±R190 000p/a towards running costs. All operational costs and the salaries of additional staff are funded out of school fees paid by the parent body and this has a significant impact on our fees. Maintaining and improving our facilities, especially our computer facilities, is also an expensive exercise but necessary if we are to provide our pupils with an excellent education.

We want to assure you, however, that every effort has been made to keep the School fee as reasonable as possible and we certainly compare favourably with our major competitors.

Glenwood's School Fee for 2012 is R26 670.00 (Grade 8 = R28 170.00) and may be paid as follows:

Full fee payment before 29 February 2012 will qualify for the following discounts.

Less 10% - Early payment: Cash, Cheque, EFT.	R23 913.00
10% off R27 570.00 = R24 813.00 + R600 = R25 413.00 less deposit R1 500	

Less 5% - Credit Card payment:	R 25 291.50
5% off R27 570.00 = R26 191.50 + R600 = R26 791.50 less deposit R1 500	

(Discounts only apply to full fee paying pupils and not to scholarship, bursary or fee remission pupils or to the capital development levy).

Less 5% - Credit Card Early Settlement R33 725.00

(Discounts only apply to full fee paying pupils and not to recipients of grants).

Per Month x 10 R 3 550.00
