ANNUAL FEE NOTICE 2025

Glenwood High School's fees for 2025 have been set out as below. In addition to the fees, all parents will contribute to a Capital Development Levy as indicated below. These figures were approved by a General Meeting of parents held on 14th November 2024. In arriving at this decision various significant factors were taken into account. The facilities and education we provide at Glenwood are funded by the fees paid by parents. We want to assure parents, however, that every effort has been made to keep the School Fees as reasonable as possible and we certainly compare favourably with our major competitors.

ANNUAL SCHOOL FEE - GRADE 8
